Official Rules

By participating in the **Hamilton Beach Canada #12DaysOfHB Facebook/Instagram Contest**, you agree to abide by the Official Rules. Hamilton Beach Canada is the official Sponsor of the Contest. The promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook/Instagram. If you do not wish to be bound by the Official Rules, you may discontinue participating in the Contest. You cannot participate in the Contest until you have accepted the Official Rules.

AGREEMENT TO OFFICIAL RULES

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE CONTEST.

2. ELIGIBILITY:

To be eligible to participate in the Contest you must have valid and public Facebook, Twitter and Instagram accounts. Entries will be deemed made by the authorized account holder of the Facebook/Instagram/Twitter account at the time the entry is submitted. Automatic entry devices are prohibited.

Facebook: Entrants must visit and follow the official Hamilton Beach Canada Facebook page, comment on one of the contest posts with the hashtag #12DaysOfHB, tag one (or three) friend(s), and follow the instructions stated in any or all of the twelve contest posts to enter. Only one Entry per post will be accepted by each Entrant during the giveaway period. Each Entrant has only one chance to enter during the giveaway period by liking the official Hamilton Beach Canada Facebook page, commenting on one of the contest posts with the hashtag #12DaysOfHB, tagging one (or three) friend(s), and following the instructions stated in any or all of the twelve contest posts from the official Hamilton Beach Canada Facebook page. Method described above is the only accepted way to submit an Entry. Any other form will be rejected. Sponsor's database computer is the official timekeeping device for the giveaway. Proof of submission is not proof of receipt.

Instagram: Entrants must visit and follow the official Hamilton Beach Canada Instagram page, comment on one of the contest posts with the hashtag #12DaysOfHB, and tag one (or three) friend(s)

in the comment area of the contest post(s). Only one Entry will be accepted by each Entrant during the giveaway period. Each Entrant has only one chance to enter during the giveaway period by visiting the official Hamilton Beach Canada Instagram page, following the page, commenting on one of the contest posts with the hashtag #12DaysOfHB, and tagging one (or three) friend(s) in the comment area of the contest post(s). Method described above is the only accepted way to submit an Entry. Any other form will be rejected. Sponsor's database computer is the official timekeeping device for the giveaway. Proof of submission is not proof of receipt.

Twitter: Entrants must visit and follow the official Hamilton Beach Canada Twitter page, comment on one of the contest posts with the hashtag #12DaysOfHB, tag one (or three) friend(s), and follow the instructions stated in any or all of the twelve contest posts to enter. Only one Entry per post will be accepted by each Entrant during the giveaway period. Each Entrant has only one chance to enter during the giveaway period by following the official Hamilton Beach Canada Twitter page, commenting on one of the contest posts with the hashtag #12DaysOfHB, tagging one (or three) friend(s), and following the instructions stated in any or all of the twelve contest posts from the official Hamilton Beach Canada Twitter page. Method described above is the only accepted way to submit an Entry. Any other form will be rejected. Sponsor's database computer is the official timekeeping device for the giveaway. Proof of submission is not proof of receipt.

Entry Requirements: All Entries must: 1) Be the original content of the Entrant; 2) Not infringe on any third-party rights; 3) Be suitable for publication as determined at the sole and absolute discretion of the Sponsor; 4) Not include, obscenity, profanity, racist themes or material that is sexually oriented or comments regarding sexual orientation, explicit, suggestive or exploits people in a sexual or violent manner; and 5) Not contain other brands' name, labels or logos. GIVEAWAY PERIOD

Entries will be accepted from 10AM ET on December 3rd to 11:59PM ET on December 14th, 2018. Entrant winners will be selected and announced on December 18th at 10AM ET. There will be twelve winners for each platform (Facebook/Instagram/Twitter).

Any incomplete entries, as determined by Hamilton Beach Canada in its sole discretion, will not be eligible. Sponsor assumes no responsibility for late, lost, incomplete, illegible, or misdirected entries.

4. CRITERIA FOR WINNERS:

The winner(s) will be chosen at random.

All participants acknowledge and agree that they are participating in the Contest for free and without having to make any purchase or payment of any kind.

The decisions on all matters relating to this Contest by the Hamilton Beach Canada Contest Team are final.

The potential winner(s) will be contacted within one business day after winner(s) determination, via Facebook/Instagram direct message. Potential winner(s) must respond to the email within 24 hours with all requested information to confirm eligibility. Contest prizes will be mailed to the winner(s). Potential winner(s) may be required to execute and return an affidavit of eligibility, release of liability, and except where prohibited, publicity release within 24 hours of notification. Noncompliance with this time period may result in disqualification and award of prize to an alternate winner. If a potential winner(s) cannot be reached, is found to be ineligible, cannot or does not comply with these Official Rules, or if any prize or prize notification is returned as undeliverable, that potential winner(s) will be disqualified and prize may be awarded to an alternate winner.
